## Additional Services

- High-speed copiers with two-sided copying for \$.15 per copy (Color copies - \$.60)
- Change made for bills up to \$20
- Basic office supplies such as regular and heavy-duty staplers, liquid correction fluid, paper clips, tape, 2 and 3-hole punch, etc.
- Printing from floppy discs, CD-RWs and USB flash drives
- **Faxing services:** \$2.00 per document (\$5.00 long-distance charge)
- **E-filing scanning:** \$2.00 per document (up to 50 pages)
- Pay with cash, check, or credit card (\$5 minimum on credit cards)

### Legal Forms

The Library has full-size, fill-in-the-blank copies of forms and instructions from the Washington State Courts, Northwest Justice Project, and other organizations for many family law topics. We also have sample forms for other areas of the law. Photocopies and computer print-outs are \$.15 per page.

### Book Check Out

Members of the public can check out library books by joining our subscriber program. The fee is \$25 for four months or \$65 for the calendar year.
